**3. Bid prices.**

b All duties, taxes and other levies payable by the bidder, shall be included in the total price. However the tax and duties livable should be quoted separately.

c. The rates quoted by the bidder shall be fixed for the duration of the contact( and shall be quoted in Indian rupees only )

d. The price should be quoted in Indian rupees only.

e. Each bidder shall submit only one quotation.

- f. Telex or Facsimile quotation are not acceptable.  
g. The firm should enclose supporting documents regarding registration of GST/  
VAT/ST/ITPAN.

#### 4. VALIDITY OF QUOTATION.

The quotation shall remain valid for a period not less than 12 month after the deadline specified for the submission of quotations.

#### 5. EVALUATION OF QUOTATIONS:

The purchaser will evaluate and compare the quotation determined to be substantially responsive i.e which are

- Properly signed and
- Confirm to the terms and conditions of specifications.
- The evaluation would be done for all the items put together. The items for which no rates have been

quoted would be treated as zero and total amount would be computed accordingly. The bidder who has quoted for partially quantity of any one or more items would be treated as non-responsive. Purchaser will award the contact to the responsive bidder whose total cost for all item put together is the lowest.

#### 6. AWARD OF CONTRACT:

- The purchaser will award the contact to the bidder whose quotation has been determined to the substantially responsive and who has offered the lowest price as per para 5 above.
- The bidder whose bid is accepted will be notified of the award of the contact by the office prior to expiration of the quotation validity period.
- The notification of award to clearly specify any change in the unit price or any other terms and conditions accepted.
- Normal commercial warranty/ guarantee shall be applicable to the supplied goods
- Payment shall be made within 30 days after delivery of goods and their acceptance.
- Notwithstanding the above, the purchaser reserves the right to accept or reject any quotation and to cancel bidding process and reject all quotation of any time prior to the award of the contact.
